Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional.

Explain:

Storm-water Basin-2.1 acres.

This man-made basin was excavated between 1992 and 1998 to provide storm water control for the developing commercial area. The Storm-water Basin is located in mapped hydric soils, however, historical aerial maps show the basin was excavated entirely in an upland area which was drained & farmed in previous decades. Historical aerial maps also show that construction of the basin did not impound, capture, or divert any 'waters of the U.S.'. Hamilton County GIS Flexviewer map shows that the basin is connected to the immediate storm-water drainage system. However, neither field observations, nor contour, aerial, IndianaMap, or GIS Flex Viewer maps provide enough conclusive evidence to prove this drainage system has significant nexus with Cheeney Creek or with any other surrounding 'waters of the U.S.'. Therefore, this Storm-water Basin does not possess any surface or subsurface hydrological connection to a 'waters of the U.S.', is not located in a floodplain, does not capture or divert any waters of the U.S., and is not susceptible to use in interstate or foreign commerce. As such, this Storm Water Basin is not a 'waters of the U.S.'

Two Ditches - 524 linear feet.

Upland Ditch 1 - 222 linear feet, Upland Ditch 2 - 302 linear feet.

These man-made ditches were excavated between 1992 and 1998 to provide storm water drainage for the developing commercial area. Upland Ditch 1 and Upland Ditch 2 are located in mapped hydric soils, however, historical aerial maps show that both ditches were excavated entirely in upland areas which were drained & farmed in previous decades. Historical aerial maps also show that excavation of the ditches did not capture or divert any existing 'waters of the U.S.'. Hamilton County GIS FlexViewer map shows that both ditches flow into the Storm-water Basin and are connected to the immediate storm-water drainage system. However, neither field observations, nor contour, aerial, IndianaMap, or GIS Flex Viewer maps provide enough conclusive evidence to prove this drainage system has significant nexus with Cheeney Creek or with any other surrounding 'waters of the U.S.'. During the site visit, Corps staff observations confirmed that Upland Ditch 1 & 2 and Storm-water Basin are connected to the immediate storm-water drainage system, yet, no surface or subsurface hydrological connection (via swales, ditches or outlets) to any surrounding 'waters of the U.S.' was found. Therefore, these ditches do not possess any surface or subsurface hydrological connection to a 'waters of the U.S.', are not located in a floodplain, do not possess any ecological connection, do not capture or divert any 'waters of the U.S.', and are not susceptible to use in interstate or foreign commerce. As such, Upland Ditch 1 and Upland Ditch 2 are not 'waters of the U.S.'

Four Isolated Wetlands - 1.40 acres.

Wetland A (forested) -0.69 acres, Wetland B (emergent) -0.10 acres.

Wetland C (emergent) – 0.02 acres, Wetland D (forested/emergent) – 0.59 acres.

Contour maps show all four wetlands to be located in an isolated depression, demonstrating that the wetlands are topographically isolated. Present and historical aerial maps show that these wetlands are not connected to the nearby drainage system, nor to any surrounding 'waters of the U.S.' through a regulated drainage system. During the site visit, Corps staff observations confirmed that all four wetlands are situated near either the Storm Water Basin and/or Upland Ditches 1 & 2, however, no surface or subsurface hydrological connection (swales, ditches or outlets) was found between these wetlands and the basin &/or ditches, nor with any surrounding 'waters of the U.S.'. Additionally, site visit observations revealed that Wetland D is much larger in size than the reported 0.06 acres. Signs of wetland criteria were found in large forested areas immediately south and west of Wetland D. (Refer to Site Visit Photos 1178a, d, e, f, & h) Estimated acreage for Wetland D is 0.59 acres.

Therefore, these wetlands do not possess any surface or subsurface hydrological connection to a 'waters of the U.S.', are not located adjacent to any waters of the U.S., are not located in a floodplain, do not possess any ecological connection, do not capture or divert any waters of the U.S., and are not susceptible to use in interstate or foreign commerce. As such, these isolated wetland are not 'waters of the U.S.'

relatively permanent tributary that is not perennial (and its adjacent wetlands if any) and a traditional navigable water, even though a significant nexus finding is not required as a matter of law.

If the waterbody⁴ is not an RPW, or a wetland directly abutting an RPW, a JD will require additional data to determine if the waterbody has a significant nexus with a TNW. If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. If the JD covers a tributary with adjacent wetlands, complete Section III.B.1 for the tributary, Section III.B.2 for any onsite wetlands, and Section III.B.3 for all wetlands adjacent to that tributary, both onsite and offsite. The determination whether a significant nexus exists is determined in Section III.C below.

SIGNIFICANT NEXUS DETERMINATION A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
