Explain: Two isolated aquatic resources, Open Water (OW) 3 and wetland 1 as identified in the submitted PCN, were identified on a 57 acre parcel of land located in Eastern Jefferson County Kentucky. A delineation was conducted on September 28, 2017 by Redwing Ecological Services Inc., and was received by the Corps for review on June 5, 2018. The proposed project area is situated in an area primarily consisting of open fields and residential development. Based on the submitted delineation, OW 3 is .098 acre(s) in size and is located in the west portion of the proposed project area. It is situated in a man-made depression resulting from previous dam construction activities with no downstream connection. Wetland 1 is an emergent wetland in the southern portion of the project areas based on the submitted delineation. It is situated in a geographical depression lacking a connection to downstream waters. Direct precipitation and adjacent surface runoff appear to provide the primary source of hydrology. Therefore, the aforementioned aquatic resources do not possess any identifiable surface or shallow subsurface hydrological connections to a "waters of the United States (U.S.)." They are not located in a floodplain and are not susceptible to use in interstate or foreign commerce. As such OW 3 and Wetland 1 are not "waters of the U.S."

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are

not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
