Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional.

Explain: A delineation conducted by the Kentucky Division of Fish and Wildlife Resources found a total of 4.05 acres of palustrine emergent wetlands within the project boundary. The wetlands were divided into three separate depressions surrounded by upland fields which did no meet the definition of a wetland due to absent of hydrophytic vegetation, hydric soils and wetland hydrology with these upland areas. The project area is continually mowed and maintained as part of a gun range within the Central Kentucky Wildlife Management Area, therefore only vegetation in the herb stratum was present on the site. The delineated wetlands are located approximately 1,800 feet or more from the upper reaches of Hays Fork, an intermittent stream at the reach closet to the project location. Review of aerial photography, topographic maps, and discussion with KDFWR staff who visited the site, all indicate that there are no drainage features which could carry flow from the wetlands to the surrounding area, or any other signs of any concentrated flow moving from the wetlands to the surrounding area. There are no signs of drainage features anywhere between the project location and Hays Fork. These wetlands are not adjacent, abutting, or otherwise connected to any tributaries that could potentially be "waters of the U.S." therefore a "Significant Nexus" finding is not required. Based on the above listed factors, the palustrine emergent wetlands identified on the site do not meet any definition of a "water of the U.S".

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW).
