C. SIGNIFICANT NEXUS DETERMINATION

B. ADDITIONAL COMMENTS TO SUPPORT JD: The review area contains the spring-fed, intermittent Stream 1 that flows into Wetland 1 which has formed within the footprint of an old farm pond. No evidence of pipes or a breach in the dam was observed during the site visit. A wetland data point was collected approximately 200' west of the base of the dam in shallow swale identified in aerial photographs as a possible connection between the wetland feature and downstream waters. It was determined that this swale was not a wetland. Therefore, Stream 1 and Wetland 1 are physically isolated in the landscape and are not "waters of the U.S."
