- B. Typical year assessment(s): The PDSI Index indicates "Severe Wetness" at the project location. The Web WIMP H2O Balance indicates the determination was conducted during a dry season. The Antecedent Precipitation Tool determined that during the 30 days prior to the date of the site inspection by the applicant (August 25, 2020) dry conditions existed at the project site. However, for the previous 90 days, the site had averaged normal conditions. The Northern Kentucky area received approximately 1.12 inches of precipitation in the week prior to the August 25, 2020 site assessment.
