Additional comments to support AJD: Wetland 1 is a non-adjacnet wetland that does not connect to any waters of the U.S. The wetland is located in the center of the property with no adjancet intermittent or perennial stream. Pond 1 is a man-made feature constructed in uplands. Aerials photographs indicate the pond was constructed in dry land between 2002-2004. Based on data provided by the consultant and data available remotely, the features onsite are considered non-jurisdictional.
