B. Typical year assessment(s): APT 1/20/2021 (Date of delineation): WETS data shows the site was drier than normal during the delineation inspection. However, the 30-day rolling precipitation total was nearly within the 30-year normal range, with precipitation occurring multiple times in the preceding month. The data does not indicate that site conditions would be atypical for the time of year that the inspection occurred.
