- B. Typical year assessment(s): A typical year assessment was developed for the site beginning April of 2017 when the original assessments and photos were taken. That year turned out drier than normal and as a result, more information was needed to determine if stream flow regime was documented appropriately. Another typical year APT assessment was developed for June of 2020 (time period for requested modification). This demonstrated that wetter than normal conditions are currently present. The permittee revisited the sites and took photographic evidence of current conditions. The photos demonstrate that the streams were still dry and since this was demonstrated under wetter than normal conditions, the Corps determined that the streams are ephemeral streams and thus not jurisdictional under the NWPR.
