Explain: The ~66 acre review area was delineated in Oct/Nov 2018 by V3 Companies. Cardno submitted V3's delineation and a request for a JD on March 27, 2019. Corps staff inspected the site on May 7, 2019, and identified multiple additional wetland areas not identified in the V3 report. On May 10, 2019, Cardno completed an additional delineation of these areas and submitted an addendum to the V3 report. The review area includes 4 identified isolated wetlands on the project site. Wetland A is 1.445 ac total (0.469 ac PEM, 0.690 ac PSS, 0.286 ac PFO). Wetland B is 1.711 acre total (0.947 ac farmed PEM, 0.764 acre PFO). Wetland C is a 0.270 acre PEM. Wetland D is

0.606 ac total (0.568 ac farmed PEM, 0.038 ac PFO). Wetlands B, C, and D are located in isolated topographical depressions on the landscape, and possess no hydrological connection to any waters of the U.S. Wetland A is an old pond that has filled in and now exhibits wetland conditions, and additional wetland area surrounds the pond outside a berm around the pond. Wetland A did not have any apparent surface connections to a waters of the U.S., however a possible subsurface connection was evaluated. A storm sewer inlet was observed at the northeast corner of Wetland A. This inlet was recently installed in the last 2 years, as part of the adjacent Chatham Hills development to the east. The consultant provided storm drainage plans for the development. The inlet extends to the east under the Monon Trail (old railroad bed), and then south into a stormwater detention pond. This pond is connected through a pipe to another detention pond to the east. A pipe leading from the second pond extends further to the east, and then north before finally out-falling to a small unnamed tributary. The total distance of the possible flowpath is 0.44 miles. In the 2 detention ponds, the inlet and outlets are set approximately 9-11 feet above the pond bottoms. The water elevation in pond 2 has to rise to approximately the 100 yr flood elevation before flowing out. While the storm drainage system has created a possible subsurface hydrological connection, the flow of water is highly controlled by the detention ponds. The infrequent ability for flow through the detention ponds extremely limits any functions Wetland A might have on a downstream TNW, and it is therefore determined to be insubstantial. The wetlands identified in the review area are not within the 100 year floodplain of any waters of the U.S., and the wetlands are not susceptible to interstate or foreign commerce. Therefore, the reported wetlands are isolated and not waters of the U.S.

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
