Other information on duration and volume: Etter Ditch begins 2 miles upstream of the site, and has a drainage area of 1.79 square miles, or about 1,200 acres. A U.S.G.S stream stats report was ran, which determined Etter Ditch has a bankfull width of 22 feet. The 10 yr peak flow was calculated to be 272 cubic feet/second, and the 1 day 10 year low flow was calculated to be 0.002 cubic feet/second. Flow was observed to be 6 inches deep in November 2019 during the consultants visit. Flow was about 6-12 inches deep during the Corps' inspection on February 3, 2020. Additionally, on a review of multiple years of aerials, flow can be seen in the stream on March 2018, August 2017, October 2016, October 2015, September 2014, and May 2010.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Etter Ditch begins 2 miles upstream of the site, and has a drainage area of 1.79 square miles, or about 1,200 acres. A U.S.G.S stream stats report was ran, which determined Etter Ditch has a bankfull width of 22 feet. The 10 yr

peak flow was calculated to be 272 cubic feet/second, and the 1 day 10 year low flow was calculated to be 0.002 cubic feet/second. Flow was observed to be 6 inches deep in November 2019 during the consultants visit. Flow was about 6-12 inches deep during the Corps' inspection on February 3, 2020. Additionally, on a review of multiple years of aerials, flow can be seen in the stream on March 2018, August 2017, October 2016, October 2015, September 2014, and May 2010. Therefore, this information demonstrates that the stream flows at least seasonally, and is considered to be an RPW.
