- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional.  
Explain: The JD review includes an identified upland man-made drainage ditch, measuring 1,490 linear feet long and approximately 8-10 feet deep within the 2.12 acre review area. The ditch originates at the west end from two storm water outfalls coming from two parking lots associated with an industrial building. Historical aerial photography was reviewed. The ditch is clearly not present in 1940, 1964, or 1972, with the area being entirely upland. The ditch appears on the 1987 aerial, and 1998-2017. The consultant indicates it is likely the ditch was

dug sometime between 1987 and 1998, about the same time the adjacent industrial building was constructed. No NWI wetlands are mapped in the area, and the soils are non-hydric. No blue line streams are present in the location of the ditch on U.S.G.S. survey maps. Based on site photos and information from the consultant and local municipality authorities, the drainage ditch only carries intermittent flow at most and does go dry. According to the 1986 preamble for the Corps implementing regulations at 33 CFR Part 328, non-tidal drainage ditches excavated on dry land are generally not considered waters of the U.S. Further, the 2007 Rapanos jurisdictional guidance for the CWA states that ditches excavated wholly in and draining only uplands, and that do not carry a relatively permanent flow of water, are not jurisdictional under the CWA. Since the ditch in question meets this criteria, it is considered an upland man-made ditch constructed wholly in and draining only uplands, and is therefore not a waters of the U.S.

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
