Explain: **Two upland man-made storm water ditches were identified in the review area. These ditches are located along the south side of an existing rail yard. They appear to have been constructed from uplands between 1953 and 1959 when the rail yard was built. The east ditch (~2,600 ft) flows to the east along the rail line and into a wastewater lagoon, which then discharges to Salem Creek. This ditch is shown as a surface stormwater line the CSX's NPDES**

**Permit No. IN0041815. The ditch on the western side (~680 ft) flows west, into a small NPDES pond on the western side of the site, and then outfalls into an unnamed tributary to Clarks Creek. This ditch is part of CSX's NPDES Permit No. INRM01276, and is located upstream of the NPDES Outfall 001. As the ditches are part of an industrial storm water and waste water NPDES permitted facility, and appear to have been constructed in uplands, the ditches are not considered to be waters of the U.S.**

### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**
