The site is primarily old field with herbaceous and young shrub growth. Wetland A was identified as a 0.47 acre PSS wetland, and Wetland B as a 0.04 acre PEM wetland. One potential hydrological connection was investigated. The Hamilton County GIS website shows a mapped storm sewer just east of the eastern side of Wetland A. Upon field investigation no storm sewer inlet was observed and it

was determined this is a buried storm line. Additionally, the wetland does not extend east to the point where the storm line is mapped. Uplands exist between these areas and there was no evidence of any water flowing out of Wetland A. Therefore, there is no hydrological or ecological connection to any waters of the U.S., the wetlands are not within the 100 year floodplain of any waters of the U.S., and the wetlands are not susceptible to interstate or foreign commerce. Therefore, these wetlands are isolated and not waters of the U.S.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
