- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional.
Explain: The review area includes 4 reported isolated wetlands and an upland erosional feature that were identified on the 35-acre project site. Reported Wetland 1 is a 0.41 acre PEM/farmed wetland, Wetland 2 is a 0.10 acre PEM/farmed wetland, Wetland 3 is a 0.03 acre PEM/farmed wetland, and Wetland 4 is a 0.06 acre PSS wetland. Wetlands 1, 2, and 3 are located in poorly drained depressions on the landscape, which have been farmed in most years. Wetland 4 is located in a depression just inside the wood line on the northeastern portion of the site. Although it is close to Ams Run, it is not located in its floodplain and no surface or subsurface connections were identified. It is

located in a closed isolated depression. Wetland 2 was reported as being connected to Ams Run via a side ditch of a new subdivision road to the east. However, no evidence of this connection was provided, and the Corps thoroughly inspected the area on August 22, 2019. No evidence of a side ditch or even a swale could be found anywhere near Wetland 2. The wetland is isolated and not connected to any waters of the U.S. As all four wetlands do not have any connection to waters of the U.S. and are not located within the floodplain of any stream, they are isolated and not waters of the U.S. Last, an upland erosional feature was identified in the farm field starting near the center of the site, and extending southeast approximately 600 feet. The feature is located entirely in uplands, does not exhibit an OHWM, and ends at a driveway on the site. It does not connect to a downstream waters of the U.S. As such, the upland erosion feature is not a waters of the U.S.

If the waterbody⁴ is not an RPW, or a wetland directly abutting an RPW, a JD will require additional data to determine if the waterbody has a significant nexus with a TNW. If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:
