Area 1 is 15.5 acres and contains one isolated emergent wetland (Wetland 10) measuring 0.09 acre. This wetland is a small cattail depression located in the middle of a farm field surrounded by higher land on all sides. Area 2 is 11.7 acres and contains one isolated scrub-shrub wetland (Wetland 07) measuring 0.05 acre. This wetland is located in a depression in an old fence row. Both identified wetlands were field

verified. There is no hydrological or ecological connection between the wetlands to any waters of the U.S., the wetlands are not within the 100 year floodplain of any waters of the U.S., and the wetlands are not susceptible to interstate or foreign commerce. Therefore, these wetlands are isolated and not waters of the U.S. The remaining area within the overall 161.7 acre development as delineated by Cardno, is being covered under a preliminary JD form. The review area for this approved JD and for the preliminary JD is clearly demarcated on the Figure 5 map by Cardno attached to both JDs.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
