Explain: The review area for the JD is 19.9 acres. One isolated wetland was identified on the site, located in a closed depression in an old field area. The majority of the site is upland row crop field. The wetland is 0.768 acre total (0.256 acre PSS/PFO and 0.512 acre PEM). No streams or drainage ways are located on-site. One intermittent blue-line is shown on the USGS quad, located along the eastern boundary of the site. However, this stream was tiled or filled long ago, and is no longer

present. The county GIS website was reviewed and there are no mapped tiles or drains are near the site. The closest open channel stream is approximately ¼ mile south of the site. There are no surface or subsurface connections to any waters of the U.S. from the reported wetland, and the site is not within the 100 year floodplain of any waters of the U.S. Therefore, the reported wetland is isolated and not a waters of the U.S.

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**
