- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional.
Explain: The review area includes 2 reported isolated wetlands and a non-jurisdictional swale that were identified on the 40-acre project site. Reported Wetland 1 is 0.11 acre PEM, and reported Wetland 2 is 0.74 acre (0.5 ac PEM and 0.24 ac PSS). Wetlands 1 and 2 are located in isolated depressions on the landscape, surrounded by row crop ground, that appear to have developed from inadequate subsurface drainage. A poorly defined swale was identified running from Wetland 1 to the south edge of the property. The swale does not exhibit a defined bed, bank, or OHWM. The swale appears to direct surface runoff to a standpipe located at the south property boundary,

however the swale continues past the standpipe onto adjacent property to the south, indicating the standpipe and any speculative tile is non-functioning. The swale dissipates and disappears in uplands just south of the property. The swale does not connect to any waters of the U.S. The county GIS website was reviewed and there are no mapped tile drains in the area. There are no surface or subsurface hydrological connections to any waters of the U.S., the wetlands are not within the 100 year floodplain of any waters of the U.S., and the wetlands are not susceptible to interstate or foreign commerce. Therefore, the reported Wetland 1 and 2 are isolated and not waters of the U.S. Additionally, the identified swale is not a waters of the U.S.

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:
