Explain: The 65 acre site is an active agricultural field. No wetlands were identified, however one grass filter strip was reported traversing the site from the northwest corner to southeast corner. This grassy filter strip/swale is observed on multiple years of aerial photography, on a portion of the site. Some years portions of it appear to be farmed through. No blue-line streams are mapped on or near the site, and no

drainage features are shown on the site in the NRCS soil survey. Upon site inspection it was observed that the feature drains only uplands, predominantly the area in between and around the on/off ramps of the I-65 and SR 44 intersection. Some active erosion has cut a small

channel in the northwest corner of the site, and also at the southeast corner. Through the middle of the site the erosional channel disappears, and no evidence of a channel or even a swale is present. The feature on the site is considered an upland erosional feature, draining only uplands, and is therefore not considered to be a waters of the U.S. The approximate length is 900 feet. The site is comprised of entirely uplands.

If the waterbody⁴ is not an RPW, or a wetland directly abutting an RPW, a JD will require additional data to determine if the waterbody has a significant nexus with a TNW. If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:
