Explain: The review area for this JD includes a 7 acre site formerly used as a dog park. The site was investigated/delineated by Civil Site Group on March 6, 2018. One emergent wetland (Wetland A) was identified in the northeast corner of the site. The wetland is reported as 0.22 acre total. Only 0.03 acre is located on the site, with the wetland extending off-site to the northeast. Also identified on the site are two roadside ditches, and open water pond measuring 0.08 acre. The pond was excavated entirely from dry land circa 2005, is not connected to

any waters of the U.S., and did not capture or divert any waters of the U.S. Therefore, it is considered an upland man-made pond. Roadside Ditch # 1 (RD1) runs west-east along the north side of the parcel along the south side of 131<sup>st</sup> St. At the eastern end it connects to Wetland A. Roadside Ditch #2 (RD2) runs along the south side of the parcel from southwest to northeast, between the parcel and the south bound lanes of I-69. Both RD1 and RD2 were constructed entirely in dry land, did not capture or divert any waters of the U.S., and do not carry a relatively permanent flow of water. The nearest identified waters of the U.S. is Sand Creek, located 0.67 miles west of the site. Although both RD1 and RD2 are both connected to Wetland A, there is no connection between the roadside ditches and a waters of the U.S. The landscape appears to rise slightly in elevation west of the site, prior to reaching Sand Creek. Both RD1 and RD2 were walked during field investigation by the Corps on June 5, 2018. It appears the both roadside ditches receive runoff from 131<sup>st</sup> St. and I-69, respectively, and then drain towards Wetland A. Wetland A is located in a small triangular area where 131<sup>st</sup> St and I-69 come together. It appears Wetland A has likely formed due to the low laying location and water runoff from the roads. This wetland was also identified as isolated in another waters investigation, as part of an INDOT I-69 road project. Therefore, Wetland (0.03 ac PEM) is considered isolated as it has no hydrological or ecological connection to any waters of the U.S., and is not susceptible to interstate or foreign commerce. Additionally, the open water pond and identified roadside ditches were constructed entirely in uplands and are not considered to be waters of the U.S.

### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
