Explain: The review area for the JD is Isolated Wetland 1 (wl 01) identified on the 233-acre project site. Isolated Wetland 1 is a 0.21 acre PEM wetland located in a linear swale in an agricultural field and old barn lot. A review of desktop information and field verification by Corps staff confirms that this wetland swale dissipates into uplands as it extends west across the farm field. Where the wetland swale ends, any flow dissipates into sheet flow across the site. There is no surface or subsurface connections to any downstream waters, and the wetland is not located within the floodplain of any stream. No evidence of a tile was observed or is mapped. Therefore the wetland is

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
