Explain: The 7.5 acre review area includes one reported isolated wetland (Wetland A – 0.48 acre PEM). The review area was included in a previous approved JD completed in 2012 (LRL-2012-187). That JD determined the entire review area, including the subject area of this JD, was entirely upland. Development in the area starting in 2013 appears to have caused Wetland A to form, particularly due to the Illinois Street extension along the western side of the site. This road construction appears to have created an isolated depression, and wetland conditions have formed in the mapped hydric soils. A culvert was reported by the consultant to lead from Wetland A, southwest under

Illinois Street. However, they were unable to determine where the culvert drains. The Corps inspected the site on June 19, 2019, to verify the delineation and investigate the potential connection. The culvert does not exit on the other side of Illinois Street, or anywhere that was observable in the field. Additionally, in the days and weeks prior to the site visit, the area had received many inches of precipitation making climatic conditions way above normal for rainfall. Water was standing in the wetland, but only a trickle was observed flowing into the culvert. It appeared the culvert may be clogged. The county GIS websites were checked, and no tile drain or storm sewer maps showed a potential connection from the wetland to a downstream water. Prior to area development, no streams were present on or near the site. Therefore, the possible connection through the culvert is unknown and speculative. There are no hydrological connections to any waters of the U.S., the wetland is not within the 100 year floodplain of any waters of the U.S., and the wetland is not susceptible to interstate or foreign commerce. Therefore, reported Wetland A is isolated and not waters of the U.S.

### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
