Explain: Four isolated wetlands were identified in the 69 acre review area. Wetland 15 is a 0.13 acre PSS wetland, Wetland 16 is a 0.06 acre PEM wetland, Wetland 17 is a 0.05 acre PFO wetland, and Wetland 18 is a 0.10 acre PEM wetland. These wetlands have formed on the site that has experienced past disturbance. There is no hydrological or ecological connection to any waters of the U.S., the wetlands are

not within the 100 year floodplain of any waters of the U.S., and the wetlands are not susceptible to interstate or foreign commerce. Therefore, these wetlands are isolated and not waters of the U.S. Additionally, one upland man-made pond (Pond 02 – measuring 0.17 acre) was identified in the review area. This pond was excavated sometime after 1998 as part of a previous failed development on the site. The pond was excavated entirely from uplands, in non-hydric soils, and is not connected to any other waters. Therefore, this upland man-made pond is not considered to be a waters of the U.S.

If the waterbody⁴ is not an RPW, or a wetland directly abutting an RPW, a JD will require additional data to determine if the waterbody has a significant nexus with a TNW. If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:
