Explain: The review area includes 3 isolated wetlands that were identified on the larger ~600-acre project site. Wetland 101 is a 0.34 acre PEM and 0.21 acre PFO wetland, Wetland 110 is a 0.05 acre PFP wetland, and Wetland 115 is a 0.05 acre PFO wetland. These wetlands were field verified on November 29, 2017 by the Corps. They are located in isolated depressions on the landscape. There are no hydrological connections to any waters of the U.S., the wetlands are not within the 100 year floodplain of any waters of the

U.S., and the wetlands are not susceptible to interstate or foreign commerce. Therefore, these wetlands are isolated and not waters of the U.S.

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
