Explain: The review area for this JD includes a 19.1 acre site. The site was investigated/delineated by Patriot Engineering in October 2017. Identified aquatic resources reported on the site include one open water pond measuring 7 acres, one forested wetland (Wetland A) reported as 1.38 acres, and one scrub-shrub wetland (Wetland B) reported as 0.38 acres. The pond appears to be an open water borrow pit that was excavated entirely from dry land sometime between 1962 and 1974, likely for the construction of the adjacent I-69 overpass. It is not connected to any waters of the U.S., and did not capture or divert any waters of the U.S. Therefore, it is considered an upland man-made

pond. Both Wetland A and B are located in isolated depressions in the landscape. Wetland A does drain into the open water pond, but there is no outlet from the pond. The wetlands are not hydrological or ecological connected to any waters of the U.S., and they are not susceptible to interstate or foreign commerce. Therefore, the identified pond and wetlands are not considered to be waters of the U.S.

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
