**Virtual Public Meeting: 6 p.m., July 7, 2020
Comment Period: June 22, 2020 to July 22, 2020**

The U.S. Army Corps of Engineers Louisville District is scheduled to host a virtual public meeting at 6 p.m., July 7, for the Fuel Storage Area and Underground Storage Tank 10 Sites at the former Kincheloe Air Force Base in Kincheloe, Michigan.

USACE officials are slated to provide a formal presentation on the Proposed Plan for the Fuel Storage Area and Underground Storage Tank 10 sites at the former Kincheloe Air Force Base.

The in-person public meeting, originally scheduled at 6:30 p.m., March 23, was cancelled due to the COVID-19 pandemic, the Centers for Disease Control and Prevention recommended guidelines for postponing or cancelling events with more than 50 people and the U.S. government's travel restrictions. The virtual public meeting will replace the in-person meeting by using technology (phone and internet) to communicate the same information to and collect comments from the public while ensuring the public safety.

USACE issued a no further action proposed plan for the Fuel Storage Area and Underground Storage Tank 10 sites (Sites). The findings and conclusion in the 2019 Final Revised Remedial Investigation Report demonstrate that contaminants of potential concern at the sites are below screening levels, indicating no further remedial action is necessary to protect human health or the environment.

Comments will be accepted until July 22, 2020. USACE will finalize its plan after reviewing all comments received during the public comment period. The no further action proposed plan may be modified based on new information and/or public comments.
