Explain: The supplemental delineation report identified two stormwater ponds noted as “Western Pond” (1.2 acres) and “Eastern Pond” (3 acres). The west pond was constructed in 2004 from dry agricultural land. At the same time, a stormwater ditch was constructed at the future site of the east pond in order to direct all stormwater to the west pond and to Klondike Creek. The east pond was then constructed in 2005. Both ponds are used solely for the purpose of capturing upland stormwater and runoff. The features were not constructed from or captures a water of the U.S.; therefore, the ponds are not waters of the U.S. and not regulated under the Clean Water Act.

### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
