Explain: The review area contains a 2,400 feet long ditch has developed as a result of erosion on top of a buried, undersized, clay drainage tile. The tile/ditch was constructed in the early 1900’s within dry land to convey agricultural runoff to the south towards Wabash River. The soil survey shows mapped hydric soils within the review area; however, available historic aerials do not show evidence that the site was anything but row crop agriculture at the time of construction. Due to the rapid urbanization of the area since the 1990’s, the drainage tile could not convey all of the runoff, causing water to flow on top (and in many places causing failure of the buried tile). The ditch was not constructed from nor captures a water of the U.S.; therefore, the ditch is not a water of the U.S. and not regulated under the Clean Water Act.

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:
