EXPLAIN RATIONALE FOR DETERMINATION THAT THE REVIEW AREA ONLY INCLUDES DRY LAND: This upland referenced on this form includes all areas within the project review area that are not identified as aquatic resources. The upland encompasses 200 acres of land. This boundary contains upland vegetation and upland soils. Erosional rills and gullies are present, however no evidence of a defined bed/bank and OHWM are visible within the upland boundary. The project location is situated within farm lands and forested watersheds.
