Consultant reports this aquatic feature as PUBHx, a pond with an unconsolidated bottom, permanently flooded, and enhanced by past excavation. County Survey map shows pond is not connected to UNT to Wildcat Creek through any regulated drainage system. Historical aerial maps show pond to be a permanent and natural aquatic feature, with no evidence of swales or ditches connecting it to UNT to Wildcat Creek. Contour map shows the pond is not connected to UNT to Wildcat Creek, demonstrating that the pond is topographically isolated. Therefore, this pond does not possess any surface or subsurface hydrological connection to a waters of the U.S., is not located adjacent to any waters of the U.S., is not located in a floodplain, does not possess any ecological connection, does not capture or divert any waters of the U.S., and is not susceptible to use in interstate or foreign commerce. As such, this pond is not a waters of the U.S.

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

- Does the tributary, in combination with its adjacent wetlands (if any), have other relationships to the physical, chemical, or biological integrity of the TNW?
