### Explain:

#### Three Isolated Wetlands – 7.54 acres.

Wetland A(1) (emergent) – 4.0 acres, Wetland A(2) (forested) – 2.42 acres, Wetland B (forested) – 1.12 acres.

The shape of the Wetland A(1) is the result of past soil excavation by the City of Indianapolis for the neighboring housing development. Historical aerial maps show that Wetland A(1) developed after soil disturbance took place in 2006, and that Wetland A(2) and Wetland B retained their original boundaries with no excavation affecting their topography. Contour maps show these wetlands to be located in an isolated depression, demonstrating that the wetlands are topographically isolated. Historical maps also show that these wetlands are not connected to any surrounding ‘waters of the U.S.’ through a regulated drainage system. During the field visit, Corps staff observed no evidence of swales, ditches or outlets connecting the wetlands to any surrounding ‘waters of the U.S.’. Therefore, these wetlands do not possess any surface or subsurface hydrological connection to a waters of the U.S., are not located adjacent to any waters of the U.S., are not located in a floodplain, do not possess any ecological connection, do not capture or divert any waters of the U.S., and are not susceptible to use in interstate or foreign commerce. As such, these isolated wetland are not ‘waters of the U.S.’

#### Detention Basin – 0.28 acres.

The basin was excavated in an upland area in 2006 to provide storm water control for the neighboring housing addition. The basin is located in mapped hydric soils; however, historical aerial maps show the area the basin was excavated in was entirely upland (drained and farmed) for decades prior to its construction. The basin was not constructed in any waters of the U.S., did not capture or divert any waters of the U.S., and is not susceptible in interstate or foreign commerce. Therefore, basin is not a waters of the U.S.

#### Ditch 1 – 140.5 linear feet.

Ditch 1 is a man-man ditch connecting Wetland A(1) to the drainage pipe leading to the Detention Basin. Ditch 1 was excavated in 2016 to provide storm water relief for the neighboring housing addition. Ditch 1 is located in mapped hydric soils; however, the area the ditch was excavated in was entirely upland (drained and farmed) for decades prior to its construction. Historical aerial maps show that this area had not developed as part of Wetland A(1) following the 2006 excavation. Neither Ditch 1, the Detention Basin, nor Wetland A(1) are connected to any surrounding ‘waters of the U.S.’ through swales, ditches or outlets. The ditch was not constructed in any waters of the U.S., did not capture or divert any waters of the U.S., and is not susceptible in interstate or foreign commerce. Therefore, Ditch 1 is not a waters of the U.S.

If the waterbody<sup>4</sup> is not an RPW, or a wetland directly abutting an RPW, a JD will require additional data to determine if the waterbody has a significant nexus with a TNW. If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. **C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
