Upland Man-made Ditch – 181 linear feet

During the site visit, Corps staff observed this ephemeral ditch to flow thru an upland forested area running along the southeast side of Parkside Drive. Corps staff observed a culvert present at the southwest end of the ditch, however, Hamilton County GIS Flex Viewer shows that this ditch is not a regulated drain, and that no regulated drains, county drains, or tile systems are present in the area. Additionally, contour maps, aerial maps, IndianaMap, and Hamilton County GIS Flex Viewer confirm that the Upland Man-made Ditch is not connected with any surrounding ‘waters of the U.S.’, and is located outside the floodplain. Corps staff found no historic evidence of the feature being a captured or diverted natural stream, neither during desktop analysis or field observation, and it is concluded that the culvert leads to a storm water drain system. Therefore, the Upland Man-made Ditch is wholly located in upland soils, is not located in a floodplain, does not capture or divert any waters of the U.S., and is not susceptible to use in interstate or foreign commerce. As such, the Upland Man-made Ditch is not a ‘waters of the U.S.’.

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
