**Wetland 1 (emergent) – 0.359 acres**

Contour maps show this wetland to be located in an isolated depression, demonstrating that the wetland is topographically isolated. Historical maps show that the wetland is not connected to any surrounding ‘waters of the U.S.’ through a regulated drainage system. During the field visit, Corps staff observed no evidence of swales, ditches or outlets connecting the wetland to any surrounding ‘waters of the U.S.’. Therefore, this wetland does not possess any surface or subsurface hydrological connection to a waters of the U.S., is not located adjacent to any waters of the U.S., is not located in a floodplain, does not possess any ecological connection, does not capture or divert any waters of the U.S., and is not susceptible to use in interstate or foreign commerce. As such, this isolated wetland is not a ‘waters of the U.S.’

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
