If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

- Does the tributary, in combination with its adjacent wetlands (if any), have the capacity to carry pollutants or flood waters to TNWs, or to reduce the amount of pollutants or flood waters reaching a TNW?

- Does the tributary, in combination with its adjacent wetlands (if any), have other relationships to the physical, chemical, or biological integrity of the TNW?

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** The review area has been manipulated and disturbed by previous attempts to develop the site. Wetlands 04, 05, 10, 20, and 29 are forested depressions surrounded by upland forest at higher elevation. Wetland 09 is a scrub-shrub depression surrounded by old field at higher elevation. Wetlands 11, 14, and 21 are emergent depressions surrounded by higher topography. Wetlands 12, 24, and 35 are scrub-shrub depressions surrounded by old field and upland forest at higher elevation. Wetland 13 is an emergent (1.26 ac) and scrub-shrub (1.15 ac) depression surrounded by old field and upland forest at higher elevation. Wetland 32 is an emergent depression surrounded by agricultural crop land at higher elevation. Wetlands 101, 102, and 103 are scrub-shrub depressions surrounded by old field and agricultural crop land at higher elevation. Pond 03 does not have an outlet and has no hydrologic connection to a WOUS. There are no possible surface or subsurface hydrologic connections from the wetlands and Pond 03, such as swales, drainage tiles, channels, etc., to any Waters of the U.S. (WOUS). Additionally, there are no known ecologic pathways or connections with any WOUS. Therefore, the wetlands and pond in question are isolated, not susceptible to use in interstate or foreign commerce, and are not considered WOUS.
