Explain: The 62 acre review area includes three separate parcels. The northern parcel is active agricultural fields, the southern parcel is a hayfield with wind turbine and substation, and the remaining parcel is a mowed lawn. No wetlands were identified in the review area; however one grass swale approximately 50 feet long was identified on the northeastern part of the site. This swale appears to be an upland man-made feature, with no defined bed/bank/OHWM. It does not connect to any waters of the U.S. No blue-line streams are mapped on or near the site. Therefore this upland swale is not considered to be a waters of the U.S. The review area is comprised of entirely uplands.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:
