B. REQUIRED ADDITIONAL COMMENTS TO SUPPORT JD. EXPLAIN RATIONALE FOR DETERMINATION THAT THE REVIEW AREA ONLY INCLUDES DRY LAND: Stream 1 was initially identified as ephemeral in nature, with a stream reach of 275 linear feet (lft). Onsite observations by Corps personnel determined that 178 lft contained within the project boundaries exhibited more upland swale features, with no defined bed/bank or Ordinary High Water elevation. The review area was determined to be an upland conveyance of runoff from surrounding areas.
