**Wetland 3 (emergent) – 0.32 acres, Wetland 4 (emergent) – 0.04 acres, Wetland 5 (shrub-scrub) – 0.13.**

Contour maps show all five wetlands to be located in an isolated depression, demonstrating that the wetlands are topographically isolated. Present and historical aerial maps show that these wetlands are not connected to any surrounding ‘waters of the U.S.’ through field tiles or a regulated drainage system. During the field visit, Corps staff observed no evidence of swales, ditches or outlets connecting Wetlands 1, 2, 3, or 4 to any surrounding ‘waters of the U.S.’. Corps staff observed Wetland 5 to drain into Pond 1, and that Pond 1 drains into an upland area along I-69 thru two outlet pipes. No stream characteristics were found within this upland area, and so, Corps staff found no evidence of swales, ditches or outlets connecting Wetland 5 or Pond 1 to any surrounding ‘waters of the U.S.’. Therefore, these wetlands do not possess any surface or subsurface hydrological connection to a ‘waters of the U.S.’, are not located adjacent to any ‘waters of the U.S.’, are not located in a floodplain, do not possess any ecological connection, do not capture or divert any ‘waters of the U.S.’, and are not susceptible to use in interstate or foreign commerce. As such, these isolated wetlands are not ‘waters of the U.S.’.

**Pond 1 – 0.89 acres.**

Pond 1 is a man-made basin excavated in 2004 to provide storm-water control for the developing commercial area. Historical aerial maps show that construction of Pond 1 did not impound, capture, or divert any ‘waters of the U.S.’, and that the basin was excavated entirely in an upland area which was drained & farmed in previous decades. Present and historical maps show no connections between Pond 1 and any surrounding ‘waters of the U.S.’ through field tiles or a regulated drainage systems. During the field visit, Corps staff observed that Pond 1 drained into an upland area along I-69 thru two outlet pipes. No stream characteristics were found within this upland area, therefore, Corps staff found no evidence of swales, ditches or outlets connecting Pond 1 to any surrounding ‘waters of the U.S.’. Therefore, Pond 1 does not possess any surface or subsurface hydrological connection to a ‘waters of the U.S.’, is not located in a floodplain, does not capture or divert any waters of the U.S., and is not susceptible to use in interstate or foreign commerce. As such, Pond 1 is not a ‘waters of the U.S.’

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. **C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
