- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional.

### Explain:

#### **Wetland 1 (emergent) – 0.12 acres**

Contour maps show Wetland 1 to be located in an isolated depression, demonstrating that the wetland is topographically isolated. Current & historical aerial maps show a swale running through the field between Wetland 1 and the Detention Pond. Johnson County GIS maps show that no field tiles are present near the wetland, demonstrating that Wetland 1 is not connected to any surrounding ‘waters of the U.S.’ through field tiles or a regulated drainage system. During the field visit, Corps staff searched along the western and southern property boundaries for any signs of surface connection, however, no evidence of swales, ditches or outlets connecting Wetland 1 to any surrounding ‘waters of the U.S.’ was observed. Therefore, this wetland does not possess any surface or subsurface hydrological connection to a ‘waters of the U.S.’, is not located adjacent to any ‘waters of the U.S.’, is not located in a floodplain, does not possess any ecological connection, does not capture or divert any ‘waters of the U.S.’, and is not susceptible to use in interstate or foreign commerce. As such, this isolated wetland is not ‘waters of the U.S.’.

#### **Detention Pond – 4.0 acres.**

This man-made basin was excavated in 2015 to provide storm-water control for the developing commercial area. Historical aerial maps show that construction of the Detention Pond did not impound, capture, or divert any ‘waters of the U.S.’, and that the basin was excavated entirely in an upland area which was drained & farmed in previous decades. Current aerial maps show a drainage pipe connecting the Detention Pond to the unnamed tributary (UNT) to Honey Creek. During the field visit, Corps staff observed the pond draining into UNT to Honey Creek, a ‘waters of the U.S.’ Corps staff found no other evidence of swales, ditches or outlets connecting the pond to any other surrounding ‘waters of the U.S.’ Therefore, the Detention Pond is a man-made storm-water basin excavated entirely in an upland area, is not located in a floodplain, does not capture or divert any waters of the U.S., and is not susceptible to use in interstate or foreign commerce. As such, this Detention Pond is not a ‘waters of the U.S.’

#### **Upland Drainage Feature – 840 linear feet**

This man-made drainage feature was excavated in 2015 to provide storm-water control for the developing commercial area. Historical aerial maps show that construction of the Upland Drainage Feature did not capture or divert any ‘waters of the U.S.’, and that the drain was excavated entirely in an upland area which was drained & farmed in previous decades. Contour maps, historical aerial maps, Johnson County GIS, and IndianaMap show that the Upland Drainage Feature is not a regulated drain, is not connected to any surrounding ‘waters of the U.S.’ through field tiles or a regulated drainage system, and is located outside the floodplain. During the site visit, Corps staff observed this ephemeral drain to begin at the southern end of the Detention Pond, flow thru an upland field area, and end at the tree line along the southern property boundary. Therefore, the Upland Drainage Feature is an ephemeral ditch excavated entirely in an upland soils, is not located in a floodplain, does not capture or divert any waters of the U.S., and is not susceptible to use in interstate or foreign commerce. As such, this Upland Drainage Feature is not a ‘waters of the U.S.’.

the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. **C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:
