Explain: Wetland A and Wetland E are non-jurisdictional wetland features which appear to have developed in a previously disturbed area. Wetland E is a depressional feature located within an agriculture field that drains via an erosional feature to Wetland A. Wetland A is a depressional feature located in an area that appears to have been disturbed between 2007 and 2008, when an adjacent facility was removed. Wetland A does not contribute flow to downstream waters. The area between Wetland A and downstream features does not exhibit indicators of flow, a defined bed/bank, an ordinary high water mark, or wetland characteristics. Wetland A and Wetland E are physically isolated in the landscape with no hydrological connection to “water of the U.S.” In addition, these features are not used nor are they susceptible to use in interstate or foreign commerce. As such, Wetlands A and E are not “waters of the U.S.”

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Wetland E is a depressional feature located within an agriculture field that drains via an erosional feature to Wetland A. Wetland A is a depressional feature located in an area that appears to have been disturbed between 2007 and 2008, when an adjacent facility was removed. Wetland A does not contribute flow to downstream waters. The area between Wetland A and downstream features does not exhibit indicators of flow, a defined bed/bank, an ordinary high water mark, or wetland characteristics. Wetland A and Wetland E are physically isolated in the landscape with no hydrological connection to “water of the U.S.” In addition, these features are not used nor are they susceptible to use in interstate or foreign commerce. As such, Wetlands A and E are not “waters of the U.S.”
