B. CHARACTERISTICS OF TRIBUTARY (THAT IS NOT A TNW) AND ITS ADJACENT WETLANDS (IF ANY):

This section summarizes information regarding characteristics of the tributary and its adjacent wetlands, if any, and it helps determine whether or not the standards for jurisdiction established under *Rapanos* have been met.

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are “relatively permanent waters” (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). A wetland that directly abuts an RPW is also jurisdictional. If the aquatic resource is not a TNW, but has year-round (perennial) flow, skip to Section III.D.2. A wetland that is adjacent to but that does not directly abut an RPW requires a significant nexus evaluation. Corps districts and EPA regions will include in the record any available information that documents the existence of a significant nexus between a relatively permanent tributary that is not perennial (and its adjacent wetlands if any) and a traditional navigable water, even though a significant nexus finding is not required as a matter of law.

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. - Discontinuous OHWM.⁷ Explain: The tributary originates from a drainage tile outfall at the eastern boundary of the review area and begins in Area A where it flows for 32 feet before briefly losing OHWM as it flows across a wide surface and back into a defined channel at Area C (335 feet). Areas A and C have developed defined channels as a result of failing drainage tile. OHWM is again lost at Wetland 1 as flow is directed into an existing subsurface drainage tile that is failing. A defined channel and OHWM appear again at Area E where the drain tile has failed, and the channel outlets to a perennial tributary to Cole Ditch.

(iii) Chemical Characteristics:

Characterize tributary (e.g., water color is clear, discolored, oily film; water quality; general watershed characteristics, etc.).

Explain: Water was present in the tributary during the inspection and appeared to be relatively clear in Areas A and C. The water was more turbid in Area E with more active scour and sedimentation in the water.

Identify specific pollutants, if known: Although specific pollutants are unknown, the tributary appeared to be originating from a failing subsurface tile on agricultural property to the north and receives flow from Area B (swale associated with Simeon Yeager drainage tile) and surrounding agricultural land, which can introduce agricultural pollutants such as nitrates, phosphates, and herbicides.

(iv) Biological Characteristics. Channel supports (check all that apply):

Summarize overall biological, chemical and physical functions being performed: The wetlands provide flood retention/storage, pollution filtration from surrounding agricultural land, and provides habitat for multiple species.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:
