The river typically is interconnected with the 45-acre open water area year-round. There is a continuous Ordinary High Water Mark extending from the shoreline of the river, through an open water connection, around the shoreline of the open water area, and back to the shoreline of the river. ### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** The review area for this jurisdictional determination is limited to the approximately 45-acre open water area that is directly connected to the West Fork of the White River. The open water feature is a former quarry pit that was originally excavated from upland agricultural fields adjacent to the West Fork of the White River. Mining operations at the site stopped in 2007, although the owner has indicated that the intent has always been to mine it again at a later time.

In 2005, in response to a violation letter from the Indiana Department of Natural Resources, and as a condition of their State permit authorizing construction in a floodway, the landowners agreed to excavate an inlet/outlet connection on the east side of the quarry pit, thereby directly connecting it to the river, in order to help alleviate downstream flooding. In 2008, a second breach due to a large flood event occurred in the southwest portion of the pit connecting the pit to an unnamed tributary to the river. This breach was never repaired. Multiple aerials spanning several years show the river freely flowing into and out of the former quarry pit through the state-permitted inlet/outlet, with the breach on the opposite side of the former pit serving as an additional hydrologic connection with the river via an unnamed tributary.

The 45-acre open water area (former quarry pit) is now interconnected with the river system. While it was once constructed from dry land, the open water area has now been connected to the river in two separate locations for 11 years. The open water area plays a role in flood protection along the river, providing storage capacity as indicated by the requirement to connect the former quarry pit to the river for the floodway permit. Therefore, the current condition of the open water area shoreline is considered a permanent change to both the river and the open water area, and the limits of waters of the U.S. have been identified in this determination accordingly. Additionally, due to the substantial interconnection with the river, the open water area now provides important ecological functions and habitat for the river system. For example, communication from recent owners has indicated that the river has brought large amounts of sediment deposits into the open water area. This sediment deposit influences the amount of sediment that moves downstream through the river system.
