**Roadside Ditch 3 – 320 linear feet**

Contour maps, current aerial maps, Benton County GIS, and IndianaMap show that Roadside Ditch (RDS) 1 & 3 are man-made features, and were created entirely in upland areas during the construction of US 41. Maps show that Roadside Ditch 1 & 3 are not regulated drains, are not connected with any surrounding regulated drains, and are not located within the floodplain. During the site visit, Corps staff observed no OHWM within either RSD 1 or 3, observed very little drainage from the ditches, and confirmed the presence of wetland features contained entirely within the banks of RSD 1 & 3. Therefore, Roadside Ditch 1 & 3 are man-made features that developed entirely in upland soils, are not located within the floodplain, do not capture or divert any waters of the U.S., and are not susceptible to use in interstate or foreign commerce. As such, Roadside Ditch 1 & 3 are not ‘waters of the U.S.’.

**Drainage Swale – 201 linear feet**

Contour maps, current aerial maps, Benton County GIS, and IndianaMap show that the Drainage Swale is not a regulated drain, is not connected with any surrounding regulated drains, and is not located within the floodplain. During the site visit, Corps staff observed no bed & bank nor OHWM within the Drainage Swale, and observed this feature to begin at RSD 1, go beneath US 41, and end at a storm water drain within RSD 3. Therefore, the Drainage Swale is a drainage feature located entirely with in upland soils, is not located in a floodplain, does not capture or divert any waters of the U.S., and is not susceptible to use in interstate or foreign commerce. As such, the Drainage Swale is not a ‘waters of the U.S.’.

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. **C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
