Road-side Ditches 1 & 2 are man-made features, both are lined with riprap and were created to provide storm-water drainage along Five Points Road & Edgewood Avenue. Photos taken by Metric Environmental show both ditches as exhibiting ephemeral flow.

Contour maps and historical aerial maps show that both ditches were created entirely in an upland area which was drained & farmed in previous decades, and that the creation of these ditches did not capture nor divert any ‘waters of the U.S.’. Aerial maps show that both ditches are connected to Little Buck Creek, however, they are not regulated drains. Therefore, both Road-side Ditches 1 & 2 are ephemeral drains created entirely in an upland area, do not capture or divert any waters of the U.S., and are not susceptible to use in interstate or foreign commerce. As such, Road-side Ditches 1 & 2 are not a ‘waters of the U.S.’.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
