Explain: The review area for the JD is a linear 1.84 acres located along the south side of 151st Street, starting at Carey Road and extending west for approximately 1,500 ft. The review area is for a planned trail project. One upland roadside drainage feature was identified near the eastern end of the site. It originates from a culvert coming under 151st from the north, draining uplands and a detention pond that was recently constructed in the uplands. The feature extends less than 100 ft to east, where it flows into a small concrete pipe under a landscape

berm, south of the roadside area. This pipe goes through the landscape berm and empties into a storm drain. Based on the county GIS website, this drain is part of an extensive storm water drain network for the adjacent subdivision. The identified feature does not exhibit a defined bed/bank/OHWM, was constructed in uplands, drains only uplands, did not capture or relocate any waters of the U.S., and does not carry a relatively permanent flow of water. Therefore, the feature is considered an upland drainage feature and is not a waters of the U.S.

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:
