- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional.
Explain: The review area for the JD is 80 acres. The consultant (Williams Creek/V3) completed separate reports for the west parcel and east parcel, but submitted them together for a JD. The sites were delineated in December 2017 and June 2018. No aquatic resources were identified on the east parcel. One isolated wetland was reported in the northwest corner of the west parcel, along the eastern edge of a woodlot. Wetland A was reported as a 0.26 acre isolated PEM wetland. Field inspection of

the wetland revealed that wetland parameters are present, however the wetland appeared slightly larger than reported. The wetland appeared to extend further to the south into the farm field, and possibly a little into the woods to the west. Additionally, farmed wetland conditions may be present to the south, southwest, and southeast, in the area of data points 4, 5, and 6. Farmed wetland conditions may also be present in the southwest corner of the site, southwest of data point 10. Saturation is present on multiple years of aerials. Due to extremely high precipitation in the preceding weeks and months, standing water was present in the possible farmed wetland areas, and verification of wetland conditions was not possible. Vegetation was absent other than soybeans that had recently been planted and were starting to emerge. No hydric soils were reported at data points 4, 4.1, 5, and 5.1. However, field inspection in the area of these data points revealed prominent depleted matrices, with redox concentrations starting at 5 inches. Therefore, the Corps cannot concur with the reported data. The standing water on site extended from the reported wetland south and to the west and east in the area of potential farmed wetlands, but ended before reaching the tree line separating the west and east parcels. There are no surface connections to any waters of the U.S. from the reported wetland, no mapped subsurface tile connections, and the site is not within the 100 year floodplain of any waters of the U.S. Therefore, the reported Wetland A, and any farmed wetlands, if present, would be isolated. The verification of isolated wetland boundaries is the responsibility of the state IDEM.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
