- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional.

Explain: A single unnamed ephemeral tributary and one emergent wetland were identified on property located in Dale, Spencer Co, Indiana directly north of Interstate 64 exit 57B. A delineation was conducted on January 25, 2017 by Redwing Ecological Services Inc on behalf of E&B Paving Inc. The proposed project area is situated in an area consisting of agricultural and commercial development. The wetland identified within the project boundaries consisted of emergent components and appears to be the result of disturbance activities on the adjacent fill facility. The unnamed ephemeral tributary does not retain characteristics consistent with jurisdictional “waters of the U.S.” and appears to disperse evenly throughout the landscape. Contour maps show the aquatic features are physically isolated in the landscape and consist mainly of closed depressions and natural low-lying areas within the project boundaries. Direct precipitation and adjacent surface runoff appear to provide the primary source of hydrology. Therefore, the aforementioned aquatic resources do not possess any identifiable surface or shallow subsurface hydrological connections to a “waters of the United States (U.S.)” They are not located in a floodplain and are not susceptible to use in interstate or foreign commerce. As such, the identified wetland and unnamed ephemeral aquatic resources are not “waters of the U.S.”

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its

proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
