Explain: Eight isolated wetlands/ponds were reported on the site. These include: 1) Large Pond (1.5 acres PUBGx), 2) North Field (0.528 acres PEM), 3) NW Small Pond (0.138 acre PSS), 4) Driveway (0.046 acre PEM), 5) Fringe (0.085 acre PFO), 6) North Ditch (0.172 acre PSS), 7) Center Field (2.11 acres PEM), and 8) Southeast Corner (0.94 acre PEM). None of the site is within a 100 year floodplain and the closest waters of the U.S. is 1,400 feet east of the property. The large pond has been present prior to 1998, is entirely open water, and has no outlet. The small pond appears to have been excavated from uplands between 2008 and 2010, but now exhibits wetland characteristics.

Besides the large and small pond areas, the majority of the site was farmed prior to 2010. Starting in 2010, a large portion of the site was significantly disturbed by dumping, filling, and soil stockpiling. This appears to have stopped around 2014-2015. It appears the wetland areas have formed since. The wetlands are located in hydric soils and topographic depressions on the landscape. The Corps inspected the site on November 4, 2019. The wetlands do not possess any surface or subsurface connections to downstream waters, and are not susceptible to use in interstate or foreign commerce. The only wetland with a possible connection was the NW small pond area. A possible “stream” was reported in this area between the NW small pond and a culvert under C.R. 750 South. Upon inspection, a discontinuous swale was observed but no defined bed/bank/OHWM. No evidence of flow was seen in this area, which is extremely flat. On the north side of the road, a grassed swale extends through the farm field, but no evidence of flow was seen. It is likely the excavated NW small pond area occasionally fills with water during the wet season, and some waters extends out into the on-site swale. However, it is very speculative that water could leave the site. Therefore, this wetland area as well as the other identified wetlands on the site are isolated and not waters of the U.S.

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
