C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The reported wetlands all lie within topographically lower areas in agricultural fields. Wetland 21 is near a manipulated stream, but a significant elevation rise exists between the wetland and stream. Wetlands 11 and 14 flow into Wetland 17, and flow is impeded by County Road 2300 East (no culvert is under the road). Wetland 16 flows west towards County Road 2300 East where it is also impeded by the road bed. Based on site contour/topographic maps and aerials, wetlands 12, 37, 38, 39, 41, and 42 potentially flow to the east/southeast during high precipitation events, but flow is impeded by County Road 2300 East. Wetlands 6, 31, and 57 are located in topographic "bowls" surrounded by higher elevation and do not flow outside their respective boundaries. There are no known hydrologic or ecologic pathways or connections with any WOUS. Therefore, the wetlands in question are isolated, not susceptible to use in interstate or foreign commerce, and are not considered WOUS.
