Wetland 1	0.494	acre(s)	(b)(1) Non-adjacent wetland.	Wetland 1 is an emergent wetland situated in a regularly maintained field adjacent to an industrial/commercial development. Wetland 1 is connected to the stormwater drainage system via Ephemeral Ditch 1 (an excluded water). It appears that stormwater runoff from the adjacent development and parking lots drains to Wetland 1, through Ephemeral Ditch 1 and continues into the stormwater drainage system, to a stormwater basin and then discharges into Northern Ditch approximately 0.5 mile away. Wetland 1 is physically isolated in the landscape from all other features except for Ephemeral Ditch and does not have the potential to receive flooding from any other waters. Therefore, Wetland 1 would be an excluded water.
Ephemeral Ditch 1	200	linear feet	(b)(3) Ephemeral feature, including an ephemeral stream, swale, gully, rill, or pool.	Ephemeral Ditch 1 appears to have been constructed to facilitate drainage from the adjacent development and parking areas. This feature drains the runoff from Wetland 1. The feature is vegetated with no defined ordinary high water mark and only drains water during precipitation events. Therefore, this feature is considered excluded.
