This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** Wetland 3, 6, 10, 17, 25, and 31 are in depressions that do not flow outside their respective boundaries. Wetland 7 is located a depression within a ditch associated with a former railroad and does not flow outside its boundaries. Wetlands 8, 11, and 12 are within isolated stormwater ponds and/or basins that were constructed in dry land and have no outlets. The reported streams 20, 21, 23, and 43 are erosional with no defined bed-and-bank and OHWM. Ditches 1-30 were constructed in dry land to convey stormwater along infrastructure associated with the former Newport Chemical Depot. The wetlands in question are isolated, and none of the aforementioned resources are susceptible to use in interstate or foreign commerce, and are not WOUS. .
