### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** Wetlands 2 and 3 lie in topographic "bowls" that are lower elevation than surrounding areas and do not flow outside their respective boundaries. Wetland 1 and its associated pond 1 appear to have formed as a result of construction of a now-abandoned railroad. A 10 inch culvert is located underneath the old railroad bed that sits several inches above ground elevation. The parcel containing the northern portion of Wetland 1 (continues off-site) appears to have been heavily manipulated since 2012, at which time a potential hydrologic connection was removed. However, the connection would have been speculative and insubstantial. There is no observed surface or subsurface flow, including through drainage tiles, that would provide a discrete connection to the White River. There are no known hydrologic or ecologic pathways or connections with any WOUS. Therefore, the wetlands in question are isolated, not susceptible to use in interstate or foreign commerce, and are not considered WOUS.
